



THE 4 P'S OF RCM PERFORMANCE

Revenue Cycle Management requires input from Patients, Providers, Payers, and our own Productivity. The speed and accuracy of the information received dictates if we will get paid, how much we will get paid, and how soon.



There are multiple entry and exit points for information throughout each of these input areas including a minimum of 15 revenue-cycle activities.
